#### Email Sent March 25th, 2021

Dear Resident,

As the snow is melting in Ballantrae we are starting to see some homes with vole/grass damage that you may not be familiar with. This grass has been damaged by voles that feed and burrow through the grass in the winter. Folks are often blissfully unaware of the activity occurring beneath the snow, until damage becomes apparent upon snow melt in March or April.

When the snow recedes and the turf first becomes visible in the spring, vole damage can appear dramatic, especially when coupled with other issues such as low temperature injury or snow mold. However, voles feed only on turfgrass shoots and the vital crown tissue and root system are typically not disturbed.

In most cases the chewed-up grass only needs to be raked up. When Melfer Property Maintenance starts their spring sweeping and power raking the mess will more than like be gone.

Please note, Owners are responsible for the damage on their own lawns. The Corporation is responsible for the damage in the common areas.

If your vole damage still requires attention you may want to apply some soil and seed to level off the areas that have been affected.

Also, some trees have bark missing from the base which is caused by animals chewing at the bark (usually rabbits and maybe squirrels). If you are concerned with the damage caused to a tree please report the issue to Property Management: <u>adam.hassan@fsresidential.com</u>

In the meantime, the existing building will be used as a gas station/office; temporary pumps will be installed soon. The house on the corner will be demolished this Spring.
