### TRUGREEN/DAVEY TREE

TruGreen completed the Grub Control Treatment on Tuesday, August 17.

Davey Tree advised the Japanese Beetle green (non-toxic) treatment was unavailable and that the red (toxic) treatment was our only recourse for the affected Lindon and Hawthorne trees. Every precaution was taken to inform everyone before and during the day of application to minimize any adverse side effects. This was successfully completed without any issues. This is not a lasting treatment but it does provide some population control. The Japanese Beetle is an invasive species with no known predators and the Board will continue to review with Davey Tree the best practices for controlling this threat to the health of our trees and gardens.
